**“Freezing Orders and Company Assets”**

### **Jeffrey Chapman QC – Fountain Court**

Jeffrey Chapman QC will discuss the current uncertain position in the law following *Group Seven Ltd v Allied Investment Corp Ltd* [2013] EWHC 1509 (Ch) and *Lakatamia Shipping Co v Nobu Su & others* [2013] EWHC 1814 (Comm), where in two separate judgments issued on the same day, the Chancery Division (Hildyard J) and the Commercial Court (Burton J) came to contrary conclusions as to whether a freezing order covers assets held by a company wholly owned and controlled by the Respondent.

**“Human Rights in Commercial Litigation – Do They Matter?”**

### **Jonathan Crow QC – 4 Stone Buildings**

The Human Rights Act 1998 has been in force for well over a decade, but even now commercial lawyers often sniff, laugh or quail at the very mention of human rights. Are they being foolish? Jonathan Crow QC provides an overview of the operation of the HRA, the specific Convention rights that are likely to be engaged in commercial litigation, and the ways in which the HRA might need to be deployed or deflected.

Charles Hollander QC’s book *“Documentary Evidence”* is well-known. Important current issues include the new doctrine of limited waiver of privilege, electronic disclosure, the extent to which the documents of one company are within the control of another company or a controlling individual, and the *Pandolfo* decision on accountants’ privilege.

**“Relief From Forfeiture – A New Lease of Life?”**

### **Kenneth MacLean QC – One Essex Court**

Kenneth MacLean QC will discuss some of the issues and lessons from the recent Privy Council decisions in the long-running litigation between *Alfa Telecom Turkey v. Cukurova Finance International* concerning the power of the Court to intervene and grant relief in the context of the enforcement of financial collateral arrangements.
