**“Courts and Litigation in 2016 and beyond”**

### **The Hon Mr Justice Birss and Ed Crosse**

After the upheaval of the Jackson reforms in 2013, civil litigators might have been forgiven for thinking that there would be a period without further substantial changes, while things bedded down. However, with several pilot schemes of new procedures currently underway and wide-ranging proposals for further changes arising from the Interim Briggs Report, there seems to be no let-up in the pace of change. The Honourable Mr Justice Birss (Chancery Division) and Ed Crosse, President of the LSLA and Partner at Simmons & Simmons LLP, will be presenting on recent developments affecting the Rolls Building Courts.
